

NOTICE is hereby given pursuant to the compliance with the provisions of Section 124(6) of the Companies Act, 2013 (the Act) and Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended from time to time (hereinafter referred to as "the Rules").

As per the applicable provisions of the Companies Act, 2013 (the Act) and the Rules, inter alia, contain the provisions for transfer of all equity shares in respect of which dividend(s) has not been paid or claimed by the shareholders for seven consecutive years or more from the date they become due, have to be transferred to the Demat account maintained by the Investor Education and Protection Fund Authority ("IEPPF Authority").

Pursuant the Rules, the original share certificate(s) which stands registered in their name will stand automatically cancelled and be deemed non-negotiable.
