WR Achieved Best Ever Loading Of 8.14 Million Tonnes In October, 2020



Ahmedabad, Western Railway is fully committed to get the best results in Mission loading, and is making all efforts to surpass its previous best figures and create new benchmarks. Under the able guidance of Shri Alok Kansal -General Manager of Western Railway, for the first time WR crossed monthly loading of 8 Million Tonnes in October 2020, by achieving its best ever loading of 8.14 Million Tonnes. This was made possible due to the energetic leadership of Shri Kansal and the dynamic team of Officers and staff who have put in a lot of effort to achieve this commendable goal.

According to a press release issued by Shri Sumit Thakur- Chief Public Relations Officer of Western Rly, the loading of 8.14 Million Tonnes for the month of October 2020, not just crossed last year's loading of 6.81 million tonnes in Oct 2019, but also the previous best loading of 7.96 Million Tonnes, achieved in January 2015. This new benchmark has been achieved after almost six years. In the month of October 2020 WR achieved average loading of 5029 wagons per day, improving previous best loading of 4673 wagons in September 2020. It is thus evident that the teams at WR are leaving no stone unturned to give their optimum to the organization and the country. This milestone could be achieved inspite of the labour constraints arisen due to Covid-19. It is worth mentioning that a number of concessions/ discounts are also being given by Indian Railways to make Railways Freight movement very attractive.Business Development Units set up at

having regular meetings with existing freight transporters, as well as prospective clients to attract them towards transport by rails. The various incentives and customer friendly initiatives that are being offered, are also highlighted to attract business. Another factor contributing to sustainable growth momentum is that the speed of freight trains have also been increased.

Shri Thakur further added that since 23rd March to 31st Oct, 2020, commodities weighing more than 1.63 lakh tonnes have been transported Western Rly through its 645 parcel special trains. which mainly included agricultural produce, agricultural

medicines, fish, milk etc. The revenue generated through this transportation, has been about Rs 55.37 crore. During this period, 112 milk special trains were run by Western Rly, with a load of more than 85 thousand tonnes and 100% utilization of the wagons. Similarly, 474 Covid-19 special parcel trains with a load of more than 52 thousand tonnes were also run to transport essential various

commodities. In addition to this, 59 indented rakes carrying about 26 thousand tonnes were also run with almost 100% utilization. During the period from 22nd March till 31st Oct, 2020, total 20,045 rakes of goods trains have been used by WR

commodities amounting to 42.98 million tonnes. 39,124 freight trains have been interchanged with other zonal railways, in which 19,518 trains were handed over and 19,606 trains taken over at different interchange points. On 1st Nov, 2020, three Parcel Special trains, including a milk rake left from various stations of WR viz. Okha to Guwahati and Dewas to Nagpur. A milk special left from Palanpur to Hind Terminal. The total loss Railway on account of Corona Virus, has been more than Rs 3137 crore, which includes about Rs 486 crore for suburban section and approx. Rs 2651 crore for non -suburban. Inspite of this, resulting to cancellation of tickets since 1st March,2020 to 31st Oct, 2020, Western Railway has ensured to return refund amount of Rs. 467.50 crore. It's worth mentioning that in this refund amount, Mumbai division alone has ensured refund of approx. Rs 228 crore. Till now, 72.73 lakh passengers have cancelled their tickets over entire Western Railway amount accordingly.

The days on which the train will be cancelled are 3rd and 24th November 2020; 1st, 8th and 15th December 2020; 19th and 26th January 2021; 2nd, 9th, 16th and 23rd February 2021 & December 2020; 1st, 8th and 30th March 2021.

Snow in HP's higher reaches disrupts traffic on Manali-Leh highway

Shimla, Traffic on the strategic Manali-Leh highway was disrupted after a fresh spell of snowfall in the higher reaches of Himachal Pradesh Monday. Kullu

superintendent of police (SP) Gaurav Singh said that vehicles are not being allowed beyond Gulaba towards Rohtang Pass though the newly inaugurated Atal Tunnel is functional. Gondla witnessed 15cm of snowfall, Zonal & Divisional levels also while Keylong got 10cm. The

higher reaches of Lahaul-Spiti, Kinnaur, Kullu and Chamba districts have been witnessing snowfall for the past few days. Light rainfall occurred in isolated parts of the state since Sunday morning. State meteorological director

Western Rly Gm Virtually Inaugurated The New Opd Block At Jagjivan Ram Hospital



Ahmedabad, Western Railway's Jagjivan Ram Hospital has earned the distinction of being the first Railway Hospital to be dedicated as COVID hospital. During the challenging times of Covid19 pandemic, JRH has ensured state of the art medical facilities and has treated more than 3500 covid patients with best recovery rate. In continuance to this, the newly renovated & revamped OPD block at Jagjivan Ram Hospital has been opened. Shri Alok Kansal - General Manager of W. Rly virtually inaugurated this newly renovated OPD block alongwith the online OPD appointment module. According to a press release issued by Shri Sumit Thakur -Chief Public Relations Officer of Western Railway, a comprehensive structural repairing work of a total area of 5500 Sq Ft was taken up under renovation, which included repairing of beams, columns, slabs, flooring and waterproofing of seepage locations. 9 OPDs have been remodelled and upgraded with air conditioning. To improve the ambience and the aesthetics, synthetic wallpapers have been used to give it a modern and swanky look. The seating capacity has been enhanced and can now accommodate around 80 visitors in the corridor as well as in reception area. Shri Thakur stated that all the OPDs have been provided with customised elevated storage, sitting arrangement and per the requirement of OPD's health staff. The washroom area (both ladies/gents) has also been given a facelift and has been

provided with concealed and PPR non-corrosive piping.

Shri Thakur informed that another notable accomplishment on this occasion was the launching of the online OPD appointment module. This will enable the patients wanting to visit JRH to take online appointment of the doctor and can book their slots 15 days in advance and patients can get the status of slot availability well in advance. This will greatly reduce the waiting period at JRH OPD and will help to avoid excess crowding thereby fulfilling the purpose of social distancing.
