## **Terms of Usage and Privacy Policy**

## Purpose and the legal basis for processing Personal Data

We process your personal data for ongoing projects, we will process your personal data to manage assignments effectively, including receiving and sending purchase orders, contracts, agreements, and for billing purposes. This processing is conducted in accordance with the legitimate interests of our mutual dealings. We do not engage in automated decision-making or profiling based on your personal data.

# Data retention

Your Personal Data will be deleted when:

- It is no longer necessary for the purposes for which you provided it.
- You withdraw your consent (where applicable).
- We are no longer legally obligated or permitted to retain it.

However, we may retain your personal data, as required by applicable laws, for specific durations.

#### Security measures for Personal Data

All personal data is stored securely in a cloud environment with multiple layers of security protocols in place to protect against unauthorized access.

# Rights

As a data principal, you have certain rights concerning your Personal Data under, *inter alia*, the Indian Digital Personal Data Protection Act, 2023 and under General Data Protection Regulation (GDPR).

Upon request and under specific conditions, you may:

- Ask for a summary of your Personal Data being processed by us;
- Ask for the identities of the entities with whom we have shared your Personal Data for processing (if at all);
- Ask for correcting, completing, updating any erasing any Personal Data;

# (Applicable to Data Principals located in the European Union)

- Obtain a copy of your Personal Data;
- Correct any inaccuracies in your Personal Data;
- Request a restriction on the processing of your Personal Data;
- Request the deletion of your Personal Data.
- Object to the processing of your Personal Data for direct communications while retaining the right to process it in our legitimate interests.
